### NOTICE PURSUANT TO KRS 13A.220

The Kentucky State Treasury has filed an amendment to our current administrative regulations found in Title 20, Chapter 1 of the Kentucky Administrative Regulations. The administrative regulations are being updated to reflect current statutory authority and practices of the Kentucky State Treasurer's Office. The specific regulations for which an amendment is sought are the following:

- 20 KAR 1:020. Unclaimed property; definitions; location of owners.

*This administrative regulation establishes a policy to locate owners of unclaimed property owners and the tools at the agencies' disposal.*
- 20 KAR 1:030. Unclaimed property; escheating.

*This administrative regulation sets out the time when unclaimed property may be claimed by the rightful owner prior to escheating to the Kentucky State Treasury. It also requires the holder to furnish the Treasury a list setting out specific items that have been returned to the rightful owner.*

*This administrative regulation establishes requirements for claims for unclaimed property.*

*This administrative regulation relates to the examination of holder records by the Kentucky State Treasury if any holder fails to make a full and complete report of property as required.*

*This administrative regulation establishes the appeals and administrative hearings process when a decision regarding unclaimed property adversely affects a person.*

*This administrative regulation establishes the rules and practices associated with a Holder of unclaimed property maintaining an interest-bearing demand, savings, or time deposit account assignable to the Department of the Treasury.*

**PUBLIC HEARING AND PUBLIC COMMENT PERIOD:** A public hearing on these administrative regulation shall be held on July 24, 2026, at 2:00 p.m., at 1050 US Highway 127 South, Suite 100, Frankfort, KY 40601. Individuals interested in being heard at this hearing shall notify this agency in writing by five workdays prior to the hearing, of their intent to attend. If no notification of intent to attend the hearing was received by that date, the hearing may be cancelled. A transcript of the public hearing will not be made unless a written request for a transcript is made. If you do not wish to be heard at the public hearing, you may submit written comments on the proposed administrative regulation. Written comments shall be accepted through June 30, 2026. Send written notification of intent to be heard at the public hearing or written comments on the proposed administrative regulation to the contact person.
